IT IS HEREBY AGREED AS FOLLOWS:

1. That I, the undersigned, do for myself or on behalf of my child, legal ward, hereby voluntarily request to participate in activities at Pinebrook Farms, which may include, but are not limited to, riding lessons, with instructor Jorine Seale, or assistant instructors approved and designated by Jorine Seale, riding on my own, allowing my family and/or friends to ride on my own hours, e and/or riding and working around horses belonging to Pinebrook Farms.

3. That I as rider and/or parent or guardian understand that upon mounting the horse, and taking up the reins, the rider is in primary control of the horse, and that the above mentioned person(s)/stable is not responsible for the results of the student's actions or inactions. The rider further agrees not to abuse, misuse or deliberately agitate the horse as these actions may result in increased risk to myself or others. I will be instructed on procedures of risk prevention, I understand that such instruction will be offered to me by the staff of Pinebrook Farms on behalf of my own safety. Should I choose to disregard these suggestion concerning safe horse management, I understand that I do so at my own risk. If my actions or performance endangers mine or other's safety I understand I may be excused from this class and course, with no compensation or credit.

4. HOLD HARMLESS AGREEMENT: I understand and agree that: These activities will be on a working horse ranch, and on and around horses. I realize that even under well supervised conditions, there is still risk involved. Horseback riding is classified as rugged adventure recreational sport activity, and that there are numerous obvious and non-obvious inherent risks always present. Horses are 5 to 15 times larger, 20 to 40 times more powerful, and 3 to 4 times faster than a human. If a rider falls from a horse to ground it will generally be at a distance of from 3 1/2 to 5 1/2 feet, and the impact may result in injury to the rider. Pinebrook Farms chooses lesson horses for their calm dispositions and sound basic training, as is required for use as riding horses for novice and beginning riders, and Pinebrook Farms follows a rigid risk reduction program. Yet, no horse is a completely safe horse. If a horse is frightened or provoked it may divert from its training and act according to its natural survival instincts which may include, but are not limited to: stopping short, changing directions or speed at will, shifting it's weight, bucking, kicking, biting, or running away from danger.

I further acknowledge that the Texas State Law (Chapter 87, Civil Practice and Remedies Code) which states that "An equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities", effective Sept. 1, 1995, applies.

I understand that these classes will be held on a working horse ranch, where tools, equipment and machinery may be used during my classes, and I will not hold Pinebrook Farms, Jorine or Harlie Seale, their family or employees or assistants, liable for any accident or injury to me, my child, any person accompanying me, or for loss or damage to my horse or to any personal property belonging to me, or any persons accompanying me, while on the premises of Pinebrook Farm or while in the care of any representative of Pinebrook Farm.

5. HEALTH FORM REQUIRED: A complete form listing any allergies, ailments or handicaps I, or any member of my family who will be a participant of Pinebrook Farm's activities, and of which the above mentioned stable should be aware of, has been attached.

6. USE OF PHOTOS, VIDEOS, ETC. I give my permission for any photograph/s or videos taken of me/my child, during class, to be used for promotional purposes without notification or compensation.
